FINAL JUDGMENT

On November 24-26, 2008, the above-referenced case was tried to a jury. On November 26, 2008, the jury rendered a verdict. Based on the jury verdict and certain stipulations of the parties, the Court finds that Plaintiff Natalynn Dunson-Harrison is entitled to judgment as follows:

IT IS ORDERED, ADJUDGED and DECREED that Defendant Engenyx Software Corporation pay to Plaintiff Natalynn Dunson-Harrison the sum of four hundred thirty-five thousand and 00/100 dollars (\$435,000.00) as actual damages, and attorney's fees through trial in the amount of thirty-five thousand and 00/100 dollars (\$35,000.00), for a total judgment of \$470,000), together with interest on said amount, which will accrue from the date of judgment at the rate of five percent (5%) per annum.

IT IS ORDERED, ADJUDGED and DECREED that Defendant Trent T. Daniel pay to Plaintiff Natalynn Dunson-Harrison the sum of two thousand nine hundred twenty-nine and 73/100 dollars (\$2,929.73) as actual damages and prejudgment interest in the amount of one hundred seventy-six and 36/100 dollars (\$176.36), for a total judgment of three thousand one hundred six and 09/100 dollars (\$3,106.09), together with interest on said amount, which will accrue from the date of judgment at the rate of five percent (5%) per annum.

IT IS FURTHER ORDERED, ADJUDGED and DECREED that in the event of an appeal to the Court of Appeals in which Plaintiff Natalynn Dunson-Harrison is successful, Defendants Engenyx Software Corporation and/or Trent T. Daniel, shall pay to Plaintiff Natalynn Dunson-Harrison the additional amount of twenty-thousand and 00/100 dollars (\$20,000.00), as additional attorney's fees, with post judgment interest to accrue on said amount at the rate of five percent (5%) per annum from the date of disposition by the Court of Appeals.

IT IS FURTHER ORDERED, ADJUDGED and DECREED that in the event a petition for review to the Supreme Court of Texas is filed by Plaintiff Natalynn Dunson-Harrison, and Plaintiff Natalynn Dunson-Harrison ultimately prevails, or in the event a petition for review to the Supreme Court of Texas is filed by Defendants Engenyx Software Corporation and/or Trent T. Daniel, and the petition is denied or Plaintiff Natalynn Dunson-Harrison ultimately prevails, Defendants Engenyx Software Corporation and/or Trent T. Daniel shall be liable to pay to Plaintiff ~~to pay to Plaintiff~~ the additional amount of ten thousand and 00/100 dollars (\$10,000.00), as additional attorney's fees, with post judgment interest to accrue on said amount at the rate of five percent (5%) per annum from the date of disposition by the Supreme Court of Texas. 702

IT IS FURTHER ORDERED, ADJUDGED and DECREED that in the event a petition is granted by the Supreme Court of Texas and Plaintiff Natalynn Dunson-Harrison is successful, Engenyx Software Corporation and/or Trent T. Daniel shall be liable to pay to Plaintiff Natalynn Dunson-Harrison the additional amount of fifteen thousand and 00/100 Dollars (\$15,000.00) as additional attorney's fees, with post-judgment interest to accrue on said amount at the rate of five percent (5%) per annum from the date of disposition by the Supreme Court of Texas.

Court costs are assessed against Defendants Engenyx Software Corporation and Trent T. Daniel, jointly and severally; and Plaintiff Natalynn Dunson-Harrison shall recover her court costs from Defendants Engenyx Software Corporation and Trent T. Daniel, jointly and severally.

All relief not expressly granted herein is denied.

THIS IS A FINAL JUDGMENT, *that disposes of all claims and all parties and is appealable.*
